**ORDER**


On April 15, 2008, Employer/Carrier's Counsel filed an Application for Formal Hearing (hereinafter "Application") with the Office of Hearings and Adjudication, Administrative Hearings Division (hereinafter "AHD"). A Scheduling Order issued on April 24, 2008, and a formal hearing was scheduled for July 10, 2008 at 9:00 a.m.

On May 5, 2008, Employer/Carrier filed a Consent Motion to Posptone [*sic*] Formal Hearing (hereinafter "Motion"). Employer/Carrier's Counsel asserted she was scheduled to appear before both the Honorable Leslie A. Meek and The Honorable Anand K. Verma on the same date and time as the formal hearing in the above-captioned matter. Employer/Carrier's Counsel offered two (2) alternative times for a formal hearing; however, the undersigned was not available at either time, and Employer/Carrier's Counsel's Motion, therefore, was Denied. Employer/Carrier's Counsel was directed to obtain Claimant's Counsel's consent to rescheduling this matter to June 25, 2008 at 2:00 p.m. or July 8, 2008 at 2:00 p.m.

On May 27, 2008, Employer/Carrier's Counsel filed a new Consent Motion to Posptone [*sic*] the Formal Hearing (hereinafter "Amended Motion"). In the Amended Motion, Employer/Carrier's Counsel indicates all parties are available for a formal hearing on July 8, 2008 at 2:00 p.m.

Upon consideration of Employer/Carrier's Counsel's Amended Motion seeking rescheduling of the formal hearing, the parties agreement regarding a date for rescheduling of the formal hearing, and a review of the official record herein, good cause having been shown, the Amended Motion is **GRANTED**. The formal hearing in the above-captioned matter is rescheduled to **July 8, 2008 at 2:00 p.m.**
