Dear Chairman Mendelson:

Pursuant to D.C. Official Code §32-771, the Department of Employment Services (DOES) respectfully submits, to the Council of the District of Columbia, the Employment Services Local Job Training Quarterly Outcome Report of Fiscal Year 2015 Quarter 1.

Historically, the agency uses local adult training funds to expand training opportunities for District residents who may not otherwise be eligible for federally-funded programs; however for fiscal year 2015, DOES has begun utilizing federal funds to support individual training account expenditures. The absence of 1st quarter training enrollments is a result of this funding transition.

Local funding will be drawn on to augment and expand the Agency's partnership with the Department of Human Services in their Temporary Assistance for Needy Families and Supplemental Nutrition Assistance Program work participation programs, as well as transportation assistance for participants. Such an alliance supports DOES's goals of expanding training opportunities for District residents and increasing their likelihood for self-sufficiency. Local funding is also being used to support the Agency's partnership with the Office of the State Superintendent for Education for the development of the Youth Re-engagement Center, as well as, fund FTE positions that are vital to the Agency's mission of putting residents back to work.

Accordingly, quarterly data and information for the period of October 1, 2014 to December 31, 2014 is submitted with this letter for your review.

Through this program, subsidized wages are paid by the Department of Employment Services while participants are in training and when placed in entry level positions with employers in the private and public sectors.

ITA: An Individual Training Account (ITA) is an account set up on behalf of an adult program to pay for training services. The purpose of the ITA is to give program participants maximum choice in selecting a training program. DOES set the amount ceiling for an ITA at \$4,000 in April 2011. ITAs are funded locally and federally. The above data reflects local funding only.

Earned GED Rate: The Agency does not currently have a licensed post-secondary education or training program or vendor offering General Education Diploma (GED), high school diploma or a non-credit bearing certificate degree at this time.

Completion: The time period covers January 2014- March 2014. The total number of completions include participants that may have started training in a previous quarter however completed in the current quarter. Additionally, the number of participants enrolled in training could vary from quarter to quarter due to exiters leaving the program.

Note: In Quarter 3 and 4 of Fiscal Year 2014, the Department of Employment Services (DOES) decided to strategically expend all available federal training funds on Individual Training Accounts (ITAs), and to predominately use Local Funds to support cohort-based training programs, including those found in the Grants and MOUs portion of the Local Adult Training Report.
