ORDER DISMISSING APPLICATION FOR REVIEW

This case is before the Compensation Review Board (CRB) on Employer/Insurer's April 26, 2017 Application for Review (AFR) of a Compensation Order issued on March 21, 2017 by the Administrative Hearings Division (AHD) in the Department of Employment Services. On May 9, 2017, Claimant filed with the CRB an opposition to Employer/Insurer's AFR.

On May 22, 2017, the Employer filed with the CRB a letter motion stating the parties have settled this claim and requesting the matter be remanded to the Office of Workers' Compensation for settlement approval.

Accordingly, Employer's AFR is dismissed without prejudice, subject to the right of either party to request reinstatement within 30 days from the date of issuance of an order by OWC related to the parties' settlement agreement.

So ordered.
