### REVISED NOTICE

March 17, 2014

Dear Employer/Insurer:

This is a revised notice being issued due to the typographical error in the Public Notice issuance dated December 12, 2013.

Pursuant to the District of Columbia Workers' Compensation Act of 1979, D.C. Official Code, § 32-1505, effective January 1, 2014, the maximum weekly compensation payment for the District of Columbia private sector workers' compensation claims is **\$1,440.00**. The minimum weekly compensation payment is **\$360.00**.

Further, in accordance with the Act, D.C. Code, as amended, § 32-1506, *Supplemental Allowance*, claimants who are permanently totally disabled, the surviving spouse or the domestic partner who are receiving indemnity payments in amounts per week less than the new maximum shall receive a supplemental allowance increase equal to 1.69% of the current benefit amount. For all cases entitled to the supplemental allowance, the employer/insurer is required to file an amended Memo of Payment of Workers' Compensation, Form No. 9 DCWC, with the Department of Employment Services – Office of Workers' Compensation, 4058 Minnesota Avenue, N.E., Third Floor, Washington, D.C. 20019.
